METHOD	APPLICATION RATE	INSTRUCTIONS
Foliar	1-1.5 quarts per 25 gal 1.5 quarts of Azogen 5-0-0 per 25 gal of water.	1.5 quarts of Azogen 5-0-0 per 25 gal of water.
Fertigation	Fertigation 50-150 ppm sheet for details.	Split application weekly. See fertigation technical
Pre-Plant	20-50 gal per acre	Apply 1-3 weeks prior to planting.
Banded	10-35 gal per acre	Apply at a depth of 3-6 inches, ensuring an effective seal of the injection track. Position the fertilizer band 3-6 inches away from the seedling or transplant.
Side-Dress	10-35 gal per acre	Apply at a depth of 3-6 inches, ensuring an effective seal of the injection track. Position the fertilizer band 3-6 inches away from the seedling or transplant.
